Dear Governor Brewer & State Legislators,

Since 2001, over \$1.7 billion has been diverted from Highway User Revenue Funds (HURF) to pay for other government programs. Now is the time to stop these transfers.

When HURF funds are properly invested in transportation projects, it provides jobs; it improves our state and local infrastructure and makes Arizona more competitive with other states. Taxpayers have a right to expect their gas tax and other vehicle-related revenues to be used for transportation improvements.

Arizona's unique and strategic location provides tremendous opportunities for economic growth through interstate and international trade. Our competitiveness will be closely tied to the ability to move commerce through the state efficiently. Infrastructure investment leads to economic expansion.

ADOT has determined that there is a \$63 billion funding gap between needs and revenues just on the state system. This year, due to the shrinking funding levels, \$350 million in planned projects and maintenance activity were eliminated from the five-year highway program. Local road systems in cities, towns and counties, which also rely heavily on HURF, are facing comparable trends.

While much of the funding shortfall can be directly attributed to the growing inadequacy of current revenue streams and the need to modernize how we pay for our roads and highways, legislative transfers have significantly contributed to the problem. To help boost our economic competitiveness and improve the everyday lives of our citizens, we urge you to eliminate the fund sweeps and return to the statutory funding formula distribution of HURF revenues to ADOT, counties, cities and towns.

SUBJECT: Mobility Management Grant

Under our contract with ADOT, the Sun Corridor MPO is responsible for the coordination of federally funded transit providers within our planning boundaries. At present, CAG is performing these duties, but as of October 1, 2015 the Sun Corridor MPO will be responsible for coordinating transit through Mobility Management activities (Coordination Council, Coordination Plan, technical assistance, etc.).

ADOT has funding available for a Mobility Management position, and the MPO will be submitting a grant application in April. The position is funded at an 80-20 match. The match portion of the grant, if awarded, will be in-kind contribution provided by our members, and other activities.

This position will coordinate our 5310 – Elderly and Disabled programs, and include the 5311 Coolidge Cotton Express and CART rural transit program. The coordination is mandatory through FTA if our 5300 programs wish to continue to receive Federal Funds.

The position is full time, and is grant funded for one year. We will apply to ADOT annually to ensure on-going activities and responsibilities are fulfilled.

The grant application process will open in February and we will have the final application completed by the March 10th meeting for your review and approval.

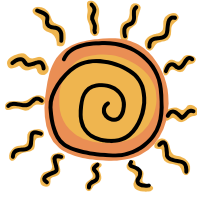
