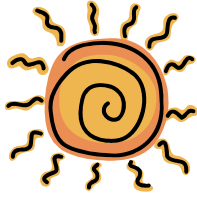

District only needs funding for a project on SR87 and Randolph Rd. Susana asked the TAC members if they had any other safety projects that they wanted to submit? If not, she has the SR87 and Randolph Rd project that she has submitted for eligibility approval.</i></p>

	<ul style="list-style-type: none"> <i>• Casa Grande - Rock N' Roll SRTS Project - The City has agreed to pay \$3,000 of their funds for the ADOT review fee to keep the project moving. The IGA will need to be amended to add the \$12K of STP funding. BIA has requested a cooperative agreement. The City is also looking at the Transit 5307 funding and would like to use some of the funding for transit/bus shelters to support the CART program within the City of Casa Grande.</i> <i>• Coolidge - The Coolidge Ave. project is complete. The task order has been submitted to ADOT for the Main St. project and they are in the process of amending the IGA. Central Ave. project is underway. A design walk was done last week to determine if it should be modernized or not. The HSIP pavement marking project is complete. Working w/ ADOT on the retroreflectivity measurements. The City of Coolidge has order over 1,000 signs, which will be delivered Monday and inspected. The Coolidge Corridor Para Study has been approved by Counsel.</i> <i>• Eloy - The Main St project will be starting a public outreach on November 17th. The HSIP Street sign project should be advertising in a few weeks. The City of Eloy will receive bids for the Shedd Road Sewer Line Extension on November 17th. The City of Eloy will receive bids for the Shedd Rd & Giles St. Reconstruction until 2pm MST December 2nd .Slurry seal projects are complete in Toltec.</i> <i>• Pinal County - Maricopa/Casa Grande Hwy Santa Cruz Wash Crossing - Right-of-way acquisition completed and design underway. Will be closing in the next few months for construction. The East-West Corridor Study - the preferred alternative was presented to the City of Maricopa and was tabled until further review.
