ITEM	 AGENDA ITEM SCMPO expects to get the RFP out for the Safety Plan by the end of October. Transit Plan is on hold until we meet with ADOT, but we expect to start the RFP in October/November. Air Quality: Still working with MAG and meeting each month We have a air quality call for project. Irene will meet with MAG and Pinal County on September 26, 2014 to discuss projects that may need to be modeled for conformity, and then will meet with Casa Grande, Coolidge and Eloy on October 2, 2014. Irene Higgs provided the updated ledgers that shows all projects and federal funding. Some discussion on how the apportionment and OA relates to our projects. MUTAC: Update on the ADOT Local Public Agency manual. There has been some updates and changes in the manual; such as; change in deadline date for projects must be submitted to the ADOT PM by June 1st for a June 30th authorization. This deadline does not apply to HSIP Projects. HSIP Projects are required to be submitted by April 15th. Another change is the construction major and minor changes from the total contract value from 5% to 20% of original contract.

10	 SCMPO has an estimated \$135K of 2015 HSIP funds left over. We will need \$30K for the 2012 projects, and will have around \$105K left. Option 1: Add \$105,000 to Safety Plan - Have the consultant complete HSIP applications for the "top to safety projects identified in the Safety Plan. This task is an HSIP eligible item. This would give total budget of \$445,348 for the Safety Plan. Loan out the remaining \$30,000 for a payback in FFY16 Option 2: Loan out \$135,000 to other COG/MPO's for future year payback. Payback of \$30,000 in FFY and \$105,000 in FFY18. Irene has been contacted by ADOT to verify the amount of Ped Heads needed for the City of Casa Grande FY15 HSIP Project. The cost could go up substantially if more Ped Heads are needed. The TAC Voted to table this until next meeting in November. Local Government project Report; Casa Grande, Coolidge, Eloy, Pinal County 				
	Coolidge: Coolidge Ave is complete, we had the ribbon cutting, it looks fantastic; Central is at 60%; Main St. is in the process of finalizing the scope of work; HSIP striping has a kick off meeting on October 7th. This project should be completed by end of October, and signs are ordered and will be available for installing in December: the City has received an ACA grant to pave Randolph Road, and is at 60% design; HSIP Safeway project is waiting on eligibility approval from ADOT.				
	Eloy: Kick off meeting held on September 18th for Main Street design; HSIP sign projects is moving forward; local projects, under design for Shed Road and HW 84 at 60%, may begin construction in January. Continuing to work on dirt roads; Begin in November to do slurry seal on all roads identified.				
	Pinal Co: 180 day review on Kelvin Road Bridge project; Doug is not as jumping happy about that. EW corridor study is starting up again, working with Maricopa and other agencies to address their concerns. Culvert project is moving forward in Maricopa at the Santa Cruz wash. Hunt Hwy, Phase I will be starting soon; PARA study in Southern Pinal County is moving forward.
